**1. REVIEW OF MINUTES OF PREVIOUS VMC MEETING**

The minutes for the previous meeting held on 06<sup>th</sup> January 2023 and action taken report was discussed in the meeting.

**a. Conduct of Interviews for the appointment of Part-Time Teachers for the year 2023-24.**

Principal informed the committee that Interviews for the appointment of Part-Time Teachers for the year 2023-24 were conducted on 7<sup>th</sup> & 10<sup>th</sup> March 2023 in the presence of Representative of the Chairman.

He further informed that the panel was prepared and approved by the Chairman, VMC and the same is displayed in the Vidyalaya website.

**b. Additional commode in the existing toilets(Middle Block) for Divyang students.**

Principal informed the committee that additional commode in the existing toilets have been installed for Divyang students in the Middle Block

**2. EXECUTION OF LEASE DEED**

Principal informed the committee that execution of lease deed of Kendriya Vidyalaya Tirumalagiri was forwarded to Director General(Lands Sec.), Defence Estate, Ministry of Defence, New Delhi ide letter no. 10130/DE/SC/L/SBD/TRIMULGHERRY dated 06-01-2017 and the same is pending.

He also expressed that Vidyalaya is unable to take up construction work due to non-execution of lease deed.

**3. HANDING OVER THE SURPLUS LAND**

Principal informed the committee details of surplus land owned by the Kendriya Vidyalaya Tirumalagiri was asked by SO (Land), HQ Telangana and Andhra Sub Area (Q), Trimulgherry, Secunderabad . He further informed that Vidyalaya has no surplus land as on date.

He also informed the committee that due to non-execution of lease deed, the details have been forwarded to the SO (land). He also requested the Nominee Chairman to reiterate the matter on the priority basis.

**4. INTERNAL RESULTS FOR THE YEAR 2022-23**

Principal has briefed the committee regarding internal results for the year 2022-23.

He further informed the committee that as per RTE Act, 2009, every Child has right for compulsory education till the class VIII. Hence, the pass percentage upto class VIII is 100%.

However, from class IX, assessment is based on student's performance. He further informed that measures are being taken to improve the performance of the detained students' in supplementary examinations scheduled from 17<sup>th</sup> to 24<sup>th</sup> April 2023.

#### 5. WITHDRAWAL OF NCC 1(T) GIRLS BATTALION

Principal informed the committee that NCC Troop with 50 girls Cadets is functioning and are trained by NCC 1(T) Girls Battalion since 2010, every year 50 girl cadets are enrolled.

He further informed that NCC 1(T) Girls Battalion has requested for holding NCC Camp in the Vidyalaya of 10 days during Autumn Break 2022-23 i.e. from 3rd to 12th October 2022. In response, KVS HQ, New Delhi has issued permission to conduct camp with the room rent @ Rs. 2,000/- per day per room apart from water and electricity charges and KVS has denied giving exemption for room rent.

He further said to the committee that Vidyalaya received a notice from Director, NCC (AP & T) for withdrawal of NCC from this Vidyalaya. He requested the Nominee Chairman to pursue the matter for the non withdrawal of NCC in the interest of the students.

The Nominee Chairman, VMC has informed to forward the details in this regard.

#### 6. ADMISSION FOR THE ACADEMIC YEAR 2023-24.

Principal informed the committee that registration for online Admissions for class I for the academic year 2023-24 has started from 27-03-2023 (Monday) at 10:00 AM onwards and last date is 17-04-2023 (Monday) till 7:00 PM.

He further informed that from Classes II to IX no fresh admissions will be taken up as the strength is above the maximum permissible limit i.e. 40 per each section and admission for class XI will be done after the declaration of Class X results.

He also brought to the notice of the committee that in KVS Admission guidelines, under Part (B), Special Provisions like MP Quota, HRM Quota, Chairman Quota, Sponsoring Agency Quota and admission of KVS grandchildren are withdrawn from 2022-23 onwards.

He also requested to nominate one of the VMC members to monitor Admission process for draw of lots scheduled on 20-04-2023 at 9:00 AM.

The Nominee Chairman, VMC has asked to submit the file for nomination of the member.

## **7. INTRODUCTION OF BALVATIKA**

Principal introduced the members of the Committee to Balvatika. He informed that Balvatika programme is envisaged as a one-year programme before Grade 1 which is meant to prepare children with cognitive and linguistic Competencies that are prerequisites for learning to read, write and develop number sense through a play-based approach.

He further informed that KVS RO has asked for the availability of rooms to initiate the Balvatika programme. He expressed that the said programme could not be initiated due to non-availability of extra class rooms.

## **8. VVN BUDGET FOR THE YEAR 2023-24.**

Principal explained the committee that Budget for Vidyalaya Vikas Nidhi for the 2023-24 has to be prepared and approved by the Executive Committee in the month of April 2023. He also said the budget has to be prepared based on Article 21 of Accounts Code, KVS.

The Nominee Chairman, VMC has asked to submit the proposal.

## **9. CELEBRATIONS OF ANNUAL DAY DURING THE MONTH OF APRIL 2023.**

Principal informed the committee that Annual Day has to be celebrated during the month of April every year as per the KVS Calendar activities. He proposed to celebrate on 28<sup>th</sup> April 2023.

The Nominee Chairman has informed the committee that date may be fixed after obtaining consent from the Chairman

## **10. ACHIEVEMENTS BY THE STUDENTS**

The Nominee Chairman appreciated the efforts of the students who have done the school proud by representing in various events. He further suggested that students achievers should be given an opportunity to address the students during morning assembly so as to motivate and inspire other students to follow the same and excel in every activity they perform.

## **11. INTERNATIONAL YEAR OF MILLETS**

The Nominee Chairman suggested that a suitable area in the School premises may be earmarked where students can be made to grow different variety of millets so as to make them understand the value of food we eat, the labour efforts by the farmers and the time taken to produce. He also suggested to organize lectures on quarterly basis by medical experts/nutritionists on the advantage of millets and healthy diet.

## **12. EXPENDITURE OF FUNDS**

The Nominee Chairman suggested that expenditure of the funds should be well thought of, for the betterment of the Vidyalaya with the aim of better educational experience of the students and staff. He also suggested that projects undertaken should be a wholesome project with clear scope of work so as to execute the work expeditiously.

### 13. POINT RAISED BY PARENT MEMBER









- a) **Whats app group for classes:** The Parent member suggested that a Parent-Teacher whatsapp groups should be created for important activities of the class and school.
