64. The quotation shall be submitted according to the terms and conditions specified in paragraphs 3 to 15. Unless specified otherwise in the quotation it shall be construed that the terms and condition stipulated hereunder have been agreed to.
65. The rate should be for and should include excise duty, sales tax, freight charges any other taxes, rates or imposition whatever liable in respect of the supplies. The Kendriya Vidyalaya shall not be liable to pay any tax, freight etc, which has not been expressly stipulated in the event of acceptance of the quotation.
66. There should not be any overwriting or correction in the quotation, if a figure is to be amended, it should be neatly scored out, the revised figure written above and the same attested with full signature and date. In the absence of the attested signature the quotation is liable to be rejected.
67. The undersigned does not bind himself to accept the lowest quotation and reserves the right to accept their quotation in whole or in part, i.e. with respect to all the article mentioned in the attached statement or in respect of any one or more than on article specified in the attached statement as he may decide.
68. On acceptance of the quotation, it will become a contract and the contractor shall be bound by the terms and condition of the quotation.
69. The person/persons whose quotation is accepted, hereinafter called the contractor, shall deposit an earnest money NIL along with the quotation which shall be refunded in the event of rejection of the quotation. The earnest money will be forfeited in the event of failure to comply with the contract. In the event of the quotation, the earnest money adjusted towards security deposit which shall be payable at the rate mentioned below

70. If the contractor fails to supply the articles within the time stipulated in letter of acceptance by the undersigned the undersigned shall be at liberty to purchase the article form the market get the rest of the contract completed by any other person or firm and the difference of price. If any, shall be deducted from the earnest money/security deposit and in case any amount in excess of the security deposit is paid by the undersigned the contractor shall be liable to pay this amount.
71. The quality of articles indicated in the attached statement may be increased or decreased at the direction of the undersigned without assigning any reason.
72. Prior to acceptance of the quotation the undersigned reserves the right to call for samples and demonstration and the contractor shall be liable to supply the samples or give the demonstration free.
